



## MiDataHub Agreements

**Data Hosting Agreement** – The Data Hosting Agreement is the sole agreement required to participate with the Michigan Data Hub. When signed the agreement authorizes your district to publish data to the Michigan Data Hub (MiDataHub). This agreement ensures that personally identifiable information and other school data will be protected, addressing topics such as FERPA, breach liabilities, the hosting of data by the MiDataHub, the access of data, and much more. This agreement is valid 10 years from the date of authorization.

**Data Hosting Agreement Waiver** – This Data Hosting agreement is required to be authorized and acknowledges a potential conflict of interest because Thrun represents Kalamazoo RESA, as MiDataHub fiscal agent, as well as districts who are current Thrun Law clients. As such, by authorizing this waiver a recommendation is that districts seek outside council to review the agreement if you have any questions or concerns.

**MICIP Opt-In Agreement** – The MICIP opt in agreement specifies the terms and conditions for use of the Michigan Integrated Continuous Improvement Process (MICIP) tool, which allows Michigan schools to create, monitor and evaluate continuous improvement plans. Signing the agreement also allows for aggregate data visualizations from MiDataHub to be used in MICIP for planning purposes. This new tool is designed around a whole-child approach and allows for use of data to identify areas for improvement, adoption of school improvement strategies and coordination of funding resources.

**MiCoachCompass Opt-In Agreement**– The MiCoachCompass opt in agreement specifies the terms and conditions for use of the MiCoachCompass system. Authorizing this agreement in the MiDataHub Cockpit enables MiDataHub to provide the required data needed for MiCoachCompass. MiCoachCompass is a platform designed to empower instructional coaches by utilizing data for growth, providing documentation and collaboration spaces, and by centering coaching around essential, research-based practices.

**MiLearn Opt-In Agreement** (optional) – The MiLearn Opt-in agreement specifies the terms and conditions for the use of data from MiDataHub in the MiLearn application. Signing this agreement also enables functionality in the MiDataHub Cockpit to configure the MiLearn system, including readiness checks against the data, authorizing report access, and more. The MiLearn tool allows students, parents, and educators to access state assessment data/reports electronically using the Student Information System portal. Those reports include M-STEP, MiAccess, and WIDA for the last 3 years.

**MiMTSS Opt-In Agreement** (Multi-Tiered System of Supports) (optional) – The MiMTSS opt in agreement specifies the terms and conditions for use of the new MiMTSS system. In the signing process, a district can also specify a primary MiMTSS Contact for that team to work with. The MiMTSS Data System is designed for use by implementation and school leadership teams who are partnering with MDE for MTSS supports. Data entered into the system are also used to annually identify schools, districts, and ISDs for MTSS recognition (positive acknowledgement of MTSS implementation efforts). At present, no MiDataHub data is used in MiMTSS, but remains a potential future option.

**[MiRead Opt-In Agreement](#)** (optional) – The MiRead Opt-In Agreement enables MiDataHub to provide the required data to the MiRead application for districts to generate individualized reading improvement plans (IRIPs) that address the 3<sup>rd</sup> Grade Reading Law. MiRead is a collaboratively created tool that was developed through partnership with MAISA and ISD-led development teams. It is designed as a comprehensive literacy portal that will continue to grow in supporting students, parents, teachers, coaches, administrators, ISDs, and the entire state. MiRead connects with a second tool called MiStrategyBank to provide instructional strategies, comprehensive supports, and reporting tools; all while leveraging ongoing work of literacy groups around Michigan.

**[Read by Grade 3 Opt-In Agreement](#)** (optional) – The Read by Grade 3 agreement will allow district data to be used for an IES Research Study led by the Education Policy Innovation Collaborative (EPIC), which includes CEPI, MDE, Michigan State University and the University of Michigan as partners. The purpose of the grant is to study the Read by Grade 3 law (RBG3) to determine the effectiveness and benefit of the law, and potentially informing future reform of the law. Data will flow through the [Michigan Education Data Center](#) (MEDC) where data will be de-identified before being analyzed and aggregated by researchers to produce final reports.
